ITSC SECURE SOLUTIONS, LLC AWARDED OASIS SMALL BUSINESS POOL 1 GWAC

FAIRFAX, VIRGINIA (April 15, 2020): ITSC Secure Solutions (ITSC) was recently awarded the GSA OASIS Small Business Pool 1 GWAC, contract number 47QRAD20D1059, under the General Services Administration (GSA) One Acquisition Solution for Integrated Services (OASIS) for Small Business (SB) Governmentwide Acquisition Contract (GWAC) Pool 1.

OASIS SB is a "Best-in-Class" Federal Acquisition Solution which meets a defined set of criteria set by the White House Office of Management and Budget, and allows government agencies to take advantage of pre-vetted industry prime contractors which will provide flexible and innovative solutions for professional services spanning many areas of expertise and mission spaces. Pool 1 consists of management, scientific, and technical services including management/business, logistics, and engineering consulting.

In addition to OASIS SB Pool 1, ITSC is the prime contractor for CEMA (Cyber-Electromagnetic Activities) instruction at the Army Cyber Center of Excellence (CCOE) Fort Gordon, Ga. for cyberspace operations, electronic warfare, and electromagnetic spectrum operations. Other areas of technical expertise include cybersecurity risk management, incidence response, information security policy and privacy, IT systems certification and accreditation (C&A), FISMA compliance, penetration testing, vulnerability assessments, digital forensics, offensive and defensive cyber, and training.

ITSC also holds two GSA PSS Schedules, GS-10F-0010U and GS-00F-065GA and is one of just sixteen Hawaii NASPO ValuePoint contract holders for State Procurement Offices for the Procurement of Acquisition Support Services (PASS).

In 2018, ITSC Secure Solutions was awarded the Nunn-Perry Award by the Department of Defense (DOD) which recognized ITSC for outstanding protégé growth, protégé business infrastructure development, HBCU Contribution, protégé technical development, and program performance formed under the auspices of the DOD MDA Small Business Mentor-Protégé Program (MP). ITSC established a Small Business Administration (SBA) All-Smalls Mentor-Protégé relationship and created an SBA Joint Venture with protégé JAM Systems; ACQ Management, an 8(a), EDWOSB, and SDVOSB JV.
